    - I'm writing with a time-sensitive request. Since Anne Reichardt died, I have learned that she still had a mortgage on her home. Because of the beneficiary deed she filed before her death, we receive not only the house but also the mortgage. St. Paul's now owes \$28,750 on that mortgage, which has an interest rate of 3.875%. After discussing options via email, the finance committee recommends we use the cash she gave the church (a little over \$31,000) to pay off the mortgage rather than begin making monthly payments.

Since payment is due on January 1 and late after January 15, I'm requesting that you vote on this matter by email.

- Email vote to approve the finance committee's recommendation to pay off the mortgage PASSED.
- Surplus Use
  - Motion that *any surplus be earmarked to a special reserve fund for maintenance* by RM, seconded by JO, motion carries
- Salaries
  - HR Committee recommends a 3% cost of living increase across the board with the exception of Sara Milford Associate Rector, who should get a 10% increase
    - Motion to accept recommendation by RM, seconded by JO, motion approves
